

**DISNEY VACATION CLUB® ART OF INSPIRATION SWEEPSTAKES
OFFICIAL RULES**

CONSUMER DISCLOSURE: NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE OR PAYMENT, WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR:** Disney Vacation Development, Inc. (“Sponsor”), 1390 Celebration Blvd. Celebration, FL 34747, U.S.A., the developer of *Disney Vacation Club* Resorts.
2. **ADMINISTRATOR:** Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, U.S.A., the independent agency administering this Sweepstakes.
3. **ELIGIBILITY:** The *Disney Vacation Club* Art of Inspiration Sweepstakes (“Sweepstakes”) is open only to individuals who are legal residents of, and physically located within the 50 United States and the District of Columbia who are at least 18 years of age, or the age of majority in their jurisdiction of residence, whichever is older, as of date of entry, and who watch *Disney Vacation Club’s* webcast (“Webcast”) or enter by Alternative Method of Entry (as further described in Section 5). “Members” must be a *Disney Vacation Club* member prior to August 7, 2019, to participate in the Sweepstakes. Officers, directors, and employees, and members of their household or immediate family (*i.e.*, parents, children, spouse, siblings, grandparents, step-parents, step-children, and step-siblings of each), and persons residing in such immediate family members' household, of Sponsor, Administrator, their respective parent, related, affiliated and subsidiary companies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors and assigns, are not eligible to enter or win. Participation constitutes full and unconditional agreement to these official rules (“Rules”). Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Sweepstakes. Winning is contingent upon fulfilling all requirements set forth herein. Void where prohibited or restricted by law.
4. **TIMING:** The Sweepstakes period begins at 12:00:00 PM (noon) Eastern Time (“ET”) on August 7, 2019, and ends at 11:59:59 PM ET on October 8, 2019 (the “Sweepstakes Period”) and consists of nine (9) separate and distinct drawings (each a “Weekly Drawing”) as outlined in the Weekly Drawings Table below and two (2) grand prize drawings (“Grand Prize Drawings”) that runs the entire length of the Sweepstakes Period. Sweepstakes registration must be completed prior to the end of the Sweepstakes Period in order to qualify as a valid entry into this Sweepstakes.

Non-winning entries will carry forward into subsequent Weekly Drawings. Administrator's computer will be the official clock for the Sweepstakes Period.

5. HOW TO ENTER:

A. Online Entry:

Register for and watch the Webcast by going to <https://artofriviera.com> ("Website"). Each entrant must provide their valid e-mail address, complete first and last name (no initials unless the initials are part of their legal name), complete street address (no PO Boxes), and daytime telephone number. Members must also provide their *Disney Vacation Club* Member ID number. Upon submission of the registration information, the entrant must then follow the on-screen prompts to watch the Webcast during the Sweepstakes Period, lasting approximately eighteen (18) minutes. Once the Webcast is concluded, the entrant must click the "Submit Entry" button to receive one (1) entry into the applicable Weekly Drawing and the Grand Prize Drawing (each an "Online Entry").

B. Mail-In Entry:

- i. To enter the Sweepstakes without watching the Webcast, each entrant may hand-write their complete name (no initials unless the initials are part of their legal name), valid e-mail address, complete street address (P.O. Boxes not accepted), and daytime telephone number on a 3½" X 5" card. Members must provide their *Disney Vacation Club* Member ID number. The completed 3½" X 5" card mailed with sufficient postage to: *Disney Vacation Club* Art of Inspiration Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325 for one (1) entry into the Weekly Drawings and the Grand Prize Drawings (each, a "Mail-In Entry"). All Mail-In Entries must be postmarked by and received by the Administrator on or before each week's Approximate Drawing Date as indicated in the Weekly Drawing Table above in order to be eligible for that week's and subsequent weeks Weekly Drawings.

Mail-In Entries must be legibly hand-written and signed by entrant. Mechanical reproductions, postage-due, or Mail-In Entries sent in excess of the Entry (as defined below) limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid Entries.

For purposes of these Rules, Online Entries and Mail-In Entries will be referred to individually as an "Entry" or collectively as "Entries". Regardless of method of Entry, there is a limit of one (1) Entry per entrant/household during the entire Sweepstakes.

6. **WINNER SELECTION:** The odds of winning a Weekly Prize (as described below) depend upon the number of eligible Entries received by each Approximate Drawing Date as indicated in the Weekly Drawings Table above. The odds of winning a Grand Prize (as described below) depend upon the total number of eligible Entries received during the entire Sweepstakes Period. On or about the Approximate Drawing Date for each respective Weekly Drawing indicated in the Weekly Drawings Table above in Section 4, Administrator will randomly select forty (40) potential weekly prize winners from all eligible Entries received by each Approximate Drawing Date (each, a "Weekly Prize Winner"). On or about October 21,

2019, Administrator will randomly select two (2) potential grand prize winners from among all eligible Entries received during the entire Sweepstakes Period (“Grand Prize Winners”). Weekly Prize Winners and the Grand Prize Winners are collectively referred to herein as “Winners”.

Administrator decisions, along with the Sponsor's, as to the administration and operation of the Sweepstakes and the selection of the potential Winners are final and binding in all matters related to the Sweepstakes. The selected entrants are each deemed a potential Winner pending verification of their eligibility and compliance with the Rules.

7. PRIZES & APPROXIMATE RETAIL VALUE (“ARV”):

A. Two (2) Grand Prizes: Each Grand Prize Winner will receive a six (6) day/five (5) night *Walt Disney World*® Resort vacation package for each Winner and up to four (4) companions (each, a “Guest”). Each Grand Prize includes: **[a]** Room accommodations consisting of one (1) 1-bedroom Villa (with a maximum of five (5) persons) for five (5) nights at *Disney’s Riviera* Resort (subject to availability); **[b]** Round trip coach airfare for five (5) people (Grand Prize Winner and up to four (4) Guests) between the major gateway airport closest to each Winner’s residence (as determined by Sponsor in its sole discretion) and the Orlando International Airport; provided, however, if either of the Grand Prize Winners resides within 250 miles of *Disney’s Riviera* Resort, in Lake Buena Vista, Florida, air fare will not be provided to that Grand Prize Winner; **[c]** Up to five (5) round trip ground transfers between the Orlando International Airport and *Disney’s Riviera* Resort via Disney’s Magical Express Transportation; provided, however, if either of the Grand Prize Winners resides within 250 miles of *Disney’s Riviera* Resort, ground transfers will not be provided to that Grand Prize Winner; and **[d]** Up to Five (5) 5-day *Walt Disney World*® theme park tickets with *Park Hopper*® Option. The ARV of each Grand Prize is \$10,387.75.

B. Three Hundred Sixty (360) Weekly Prizes (40 per Weekly Drawing): Each Weekly Prize Winner will receive a \$25 Disney eGift Card. The Disney eGift Card can be used at select participating locations at Walt Disney World® Resort, Disneyland® Resort, Disney Cruise Line, Disney store locations in the U.S., Canada, and Puerto Rico, shopDisney.com, and Adventures by Disney®. Visit DisneyGiftCard.com for complete terms and conditions. The Disney eGift Card must be redeemed by December 31, 2019, once the Disney eGift card is redeemed, it does not expire. The ARV of each Weekly Prize is \$25. The total ARV of all Weekly Prizes is \$9,000.

C. Total ARV: The total ARV of all prizes available in the Sweepstakes is \$29,775.50. For all Grand Prizes, actual value of a Grand Prize depends on the date/time of arrival, number of Guests, and fluctuation of airfare and hotel rates; any difference between the stated ARV and actual value will not be provided.

D. Prize Conditions: All expenses not specifically mentioned herein are not included in the prizes and are solely the Winners responsibility, including, but not limited to, airfare and ground transportation between the Grand Prize Winners’ residences and major gateway

airports and ground transportation between the Grand Prize Winners' residences and *Disney's Riviera Resort*, at *Walt Disney World*[®] Resort, in Lake Buena Vista, Florida, if either Grand Prize Winner resides within 250 miles of *Disney's Riviera Resort*. Each Guest who accompanies a Grand Prize Winner must be at least 18 or the age of majority in their jurisdiction of residence, unless such Guest is the child or legal ward of such Grand Prize Winner or another adult Guest. If a Guest is a minor and not the child or legal ward of such Grand Prize Winner, the parent/legal guardian of such Guest must also accompany the minor Guest. Each Guest may be required to submit guest releases to Sponsor upon Sponsor's request, within a certain time period to be determined by Sponsor.

Each Winner's acceptance of a prize and/or the participation in a prize by a Winner and any Guest(s) of a Grand Prize Winner constitutes the grant to Sponsor and Sponsor's affiliates of an unconditional right and license to use the Winner's and their Guest(s)' full name (if applicable), any aliases, social media account names, biographical data, voice, and reproductions or renderings of physical likeness (as the same may appear in any still camera photograph, video, and/or any other form), in whole or in part, in all media formats, platforms, and channels now known or hereafter devised, in perpetuity, throughout the universe, for any and all purposes, including, but not limited to advertising, promotion, marketing, publicity, trade or commercial purposes, all without further notice to the Winners and/or their Guest(s), with or without attribution, and without compensation, except where prohibited by law, and Winners and their Guest(s) hereby release the Releasees (as defined below in Section 9) from any claims or liability arising out of or with respect to such use.

Each Grand Prize must be completed by May 31, 2020 with a 60 day travel advance (certain restrictions and other block-out dates may apply; block-out dates include December 23, 2019 through January 1, 2020).

All Guest(s) of each Grand Prize Winner must stay in the same villa as that Grand Prize Winner. If a Grand Prize Winner elects to partake in their prize with fewer Guests than allowed for or no Guests, no additional compensation will be awarded to that Grand Prize Winner. All prize-related travel arrangements will be determined and administered by Sponsor or Sponsor's authorized designee. The Grand Prize travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. Grand Prize Winners and their Guest(s) will be required to travel on identical itineraries including the same departure date and return date. Air

transportation and hotel accommodations must be taken together and cannot be taken separately. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Sponsor's sole discretion. All airline tickets issued in conjunction with the each Grand Prize are not eligible for upgrades, frequent flyer miles or any other promotional benefit. Sponsor is not obligated to replace any lost or stolen tickets (including any event tickets or admission passes), travel vouchers, certificates, or similar items once they are in either Grand Prize Winner's possession or in the possession of any Guest of a Grand Prize Winner. Air travel must be roundtrip. Sponsor will determine the flight itinerary in its sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. Air travel is subject to the terms and conditions set forth in these Rules and those set forth by Sponsor's air travel prize supplier, as detailed in the passenger ticket contract issued by such supplier. If either Grand Prize Winner elects to partake in the Grand Prize with fewer Guests than specified or no Guests, airfare, ground transportation and theme park tickets will be awarded in increments only for the actual number of confirmed travelers on the reservation and no substitute prize elements or additional compensation will be awarded to such Grand Prize Winner.

Each Grand Prize Winner and their Guests are solely responsible for obtaining any desired or necessary travel documents (including but not limited to government-issued photo identification). Grand Prize Winners and their Guests hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the Grand Prize.

Each Grand Prize Winner will be required to provide a major credit card upon hotel check-in or prior thereto and all in-room charges will be charged to the credit card. Any damage to the room, and/or any other venue related to the Grand Prize, attributed to either Grand Prize Winner and/or their Guests will be the responsibility of that Grand Prize Winner.

SPONSOR, ITS PARENT, RELATED, AFFILIATED, AND SUBSIDIARY COMPANIES AND THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, EMPLOYEES AND ASSIGNS ARE HEREBY RELEASED AND DISCHARGED FROM ANY AND ALL LEGAL CLAIMS, LOSSES, EXPENSES, LIABILITIES, INJURIES, DEMANDS, DAMAGES, ACTIONS, AND/OR CAUSES OF ACTION THAT ARISE OUT OF AND/OR ARE IN ANY WAY RELATED TO A PRIZE, THE RECEIPT, USE AND/OR ENJOYMENT OF A PRIZE AND/OR THE SWEEPSTAKES. All benefits and payments are personal to each Winner and are not redeemable for cash and are neither assignable nor transferable.

Any portion of a prize not accepted or used by a Winner will be forfeited, and Sponsor shall not be responsible for any inability of a Winner to accept or use any portion of their prize for any reason. No substitution or transfer of a prize is allowed except with Sponsor's permission or where required by law. If for any reason a prize becomes unavailable, Sponsor may award a substitute prize of equal or greater value. Award of a prize is subject to verification of eligibility and compliance with these Rules. Upon verification of eligibility, Sponsor's designee will contact each Grand Prize Winner to book the stay. All prizes will be awarded provided a sufficient number of eligible Entries are received.

There is a limit of one (1) Grand Prize and one (1) Weekly Prize per person, per household.

- 8. NOTIFICATIONS TO WINNERS AND REQUIREMENTS TO CLAIM A PRIZE:** Each potential Winner will be notified by e-mail and/or telephone within two (2) business days from the random drawing set forth in Section 4 and Section 6 of these Rules. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: **[a]** a potential Winner's failure to respond to Administrator's verification e-mail within two (2) calendar days from the date the verification e-mail is sent; **[b]** the e-mail notification sent by Sponsor/Administrator is returned as undeliverable after three (3) attempts; **[c]** a potential Winner's failure to provide Administrator with satisfactory proof of age, identity and residency; **[d]** a potential Grand Prize Winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release (including, without limitation, their Social Security Number as required by law) within five (5) calendar days from the date the form is sent to each potential Grand Prize Winner. **Federal, state and local taxes and all other expenses not specified herein are the Winner's sole responsibility. The award of a prize is subject to applicable withholding requirements.** In the event that a potential Winner is disqualified for any reason or does not accept their prize, Sponsor, in its sole and absolute discretion, will award the prize to an entrant selected at random from the remaining eligible Entries received for the applicable drawing, subject to verification of eligibility and compliance with these Rules. In such case where a prize is not accepted or where a Winner has forfeited, there will, as necessary, be up to three (3) alternate Winners contacted, after which the prize, if not accepted by an eligible Winner, will not be awarded.

INTERNET/LIMITATIONS OF LIABILITY:** Sponsor, Administrator, their respective parent, related, affiliated and subsidiary companies, their advertising, promotion and web design agencies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors, assigns, directors, officers, employees, agents and independent contractors (individually and collectively, "Releasees"), are not responsible for technical malfunctions of any kind, including but not limited to interrupted or unavailable network server or other connections; miscommunications; failed, partial, or garbled telephone or computer transmissions; jumbled, scrambled, or misdirected Entries or transmissions; phone, electrical, network, computer hardware or software or program malfunctions, failures or difficulties; other errors, omissions, interruptions, or deletions of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; or for any damage to any person's computer or wireless device related to the Sweepstakes, including without limitation, participation in the Sweepstakes. Additionally, Releasees are not responsible for illegible, unintelligible, late, lost, damaged, stolen, or postage-due Entries; incorrect or inaccurate Entry information, whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes; or for any technical or human errors which may occur in the processing of any Entries in the Sweepstakes. Any person attempting to enter using multiple identities or any other device or artifice to enter multiple times in contravention of these Rules, or to interfere with the proper administration of the Sweepstakes, will be disqualified from participation in the Sweepstakes. Additionally, any use of robotic, automatic, macro, programmed, third party

or like methods to participate in the Sweepstakes will void any attempted participation effected by such methods and result in the disqualification of any individual utilizing the same. Sponsor and/or Administrator reserves the right to disqualify any individual found or suspected, in its sole opinion, to be tampering with the operation of the Sweepstakes; to be acting in violation of these Rules; or to be acting with the intent to disrupt the normal operation of the Sweepstakes. If, in the judgment of Sponsor and/or Administrator, the Sweepstakes is compromised by viruses, bugs, non-authorized human intervention or other causes that corrupt or inhibit, or may corrupt or inhibit the administration, security, fairness or intended proper play of the Sweepstakes, so that it cannot be conducted as originally planned or intended, Sponsor and/or Administrator have the right, in their sole respective discretion, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes (except where prohibited by law); and in such event, to select the Winners by such method as Sponsor in its sole discretion shall consider equitable. **RELEASEES MAKE NO WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT AS REGARDS TO THE SWEEPSTAKES, ANY PRIZE OR ANY COMPONENT OF A PRIZE OR THE SWEEPSTAKES. AS SOME JURISDICTIONS MAY NOT ALLOW LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES, CHECK YOUR LOCAL LAWS TO LEARN IF ANY OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY APPLY TO YOU.**

10. PRIVACY POLICY AND TERMS OF USE: Any personally identifiable information collected during an Entrant's participation in the Sweepstakes is subject to Sponsor's privacy policy (<https://disneyprivacycenter.com/>). In the event of a conflict between Sponsor's terms of use and the Rules, the Rules will prevail.

11. GOVERNING LAW: The terms of this Sweepstakes shall be governed by, construed under, interpreted and enforced in accordance with the laws of the State of Florida without regard to conflicts of laws provisions thereof. Any dispute or claim arising out of or in connection with this Sweepstakes or these Rules shall be resolved individually, without resort to class action, and submitted exclusively to the Circuit Court in and for Orange County, Florida USA (or if the Circuit Court shall not have jurisdiction over the subject matter thereof, then to such other court sitting in such county having subject matter jurisdiction) for trial and determination by the court sitting without a jury. **All Entrants consent to the jurisdiction of such court and to the service of process outside the State of Florida pursuant to the requirements of such court in any matter submitted to it, AND THEY EXPRESSLY WAIVE THE RIGHT TO A JURY TRIAL.** ANY CLAIM FOR DAMAGES SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING, WITHOUT LIMITATION, ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM. ONLY SPONSOR AND/OR ADMINISTRATOR MAY RESCIND THIS SWEEPSTAKES AND/OR SEEK INJUNCTIVE AND/OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR RELEASEES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY CLAIM

MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION OCCURRED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

RELEASE: By participating, each entrant releases and agrees to indemnify and hold harmless Releasees from and against any and all costs, claims, liabilities, damages, or any other injury, whether due to negligence or otherwise, to person(s) or property (including, without limitation, death or violation of any personal rights, such as violation of right of publicity/privacy, libel, or slander), due in whole or in part, directly or indirectly, to participation in the Sweepstakes, or arising out of participation in any Sweepstakes or Sweepstakes-related activity, or the receipt, use, or misuse of a prize.

13. GENERAL TERMS & AGREEMENT TO RULES: By entering the Sweepstakes, entrants agree to be bound by and abide by these Rules. The Sweepstakes is subject to all applicable federal, state, and local laws.
